

March/April 2019 – Weekly Prize Draw to Win Back Travel Money Purchase

1. The weekly prize draws are for the chance to win back the amount you paid for your foreign exchange purchase (collectively referred to as “Prize Draws” and each a “Prize Draw”).
2. There will be four (4) Prize Draws held as follows (the “Competition Periods”):
 - (a) Prize Draw 1 opens from 12:00 a.m. on Monday 11th March 2019 and closes at 11:59 p.m. on Sunday 17th March 2019.
 - (b) Prize Draw 2 opens from 12:00 a.m. on Monday 18th March 2019 and closes at 11:59 p.m. on Sunday 24th March 2019.
 - (c) Prize Draw 3 opens from 12:00 a.m. on Monday 25th March 2019 and closes at 11:59 p.m. on Sunday 31st March 2019.
 - (d) Prize Draw 4 opens from 12:00 a.m. on Monday 1st April 2019 and closes at 11:59 p.m. on Sunday 7th April 2019.
3. To enter into a Prize Draw, you must:
 - (a) Successfully complete a single foreign exchange reserve and collect transaction with Moneycorp at www.moneycorp.com/en-gb/travel-money/reserve-and-collect/ with a pound sterling value between £500.00 and £1,000 (the “Qualifying Transaction”) during one of the Competition Periods. Explorer multi-currency MasterCard re-loads are exempt from this Prize Draw; and
 - (b) Opt-in to receive email marketing from Moneycorp at the point of ordering your currency at www.moneycorp.com/en-gb/travel-money/reserve-and-collect/.
4. Subject to satisfying clause 3, you will be entered into the Prize Draw which was open at the time you successfully completed the Qualifying Transaction (a “Successful Entry”).
5. Moneycorp will carry out each respective Prize Draw at the end of each individual Competition Period. For each Prize Draw, one (1) winner will be selected at random from the participants and will be notified, via email, within fourteen (14) days of the Prize Draw taking place.
6. If the winner selected cannot be contacted, or has not responded within fourteen (14) days of being contacted, Moneycorp reserves the right to select another winner at random. Unsuccessful participants will not be contacted.
7. The prize for each Prize Draw is a pound sterling refund of the Qualifying Transaction (the “Prize”).
8. The Prize will be awarded by bank transfer only and the winner must provide their applicable bank details on being notified of winning the Prize Draw under clause 5.
9. Subject to satisfying Clause 8, the winner will be awarded the Prize within fourteen (14) days of providing their applicable bank details.
10. Each Successful Entry will constitute an individual entry into the respective Prize Draw.
11. Moneycorp will not be liable for any bank charges or fees you incur as a result of claiming the Prize.

12. By entering into a Prize Draw, the participant consents to Moneycorp processing its personal data (name, email address, telephone number and (if successful) bank details) for the purposes of administering the Prize Draw. 13. Moneycorp will not be liable:
 - a. for unsuccessful attempts to enter into a Qualifying Transaction during the Competition Periods for any reason;
 - b. for circumstances which prevent Moneycorp from fulfilling the Qualifying Transaction during the Competition Periods;
 - c. for any delay in awarding the Prize to you; or
 - d. in the event that the law or any regulatory guidance prevents Moneycorp from continuing this promotion.
14. Events may occur which render the Prize Draws impossible due to reasons beyond Moneycorp's control and accordingly Moneycorp reserves the right, in its absolute discretion, to withdraw, amend or vary the terms of this Prize Draws at any time and you agree that no liability shall attach to Moneycorp as a result of such withdrawal, amendment or variation.
15. The Prize Draws are not open to Moneycorp employees or any member of their immediate family, namely a spouse, child, sibling or parent.
16. Your Qualifying Transaction is subject to Moneycorp's standard travel money terms and conditions, as amended from time to time.
17. These terms and conditions shall be construed in accordance with the laws of England and Wales.
18. Moneycorp and the participants agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with these terms and conditions or their subject matter or formation.
