

## Terms and Conditions

### **August/September 2019 – Fortnightly prize draw to win a set of Beats EP On-Ear Headphones**

1. The fortnightly prize draws are for the chance to win a set of Beats EP On-Ear Headphones (collectively referred to as "Prize Draws" and each a "Prize Draw").
2. The Prize Draws are open to United Kingdom residents (excluding Northern Ireland) only.
3. There will be two (2) Prize Draws held as follows (the "Competition Periods"):
  - (a) Prize Draw 1 opens from 12:00 a.m. on Monday 19th August 2019 and closes at 11:59 p.m. on Sunday 1st September 2019.
  - (b) Prize Draw 2 opens from 12:00 a.m. on Monday 2nd September 2019 and closes at 11:59 p.m. on Sunday 15th September 2019.
4. To enter into a Prize Draw, you must:
  - (a) Successfully complete a single foreign exchange reserve and collect transaction with Moneycorp at [www.moneycorp.com/en-gb/travel-money/reserve-and-collect/](http://www.moneycorp.com/en-gb/travel-money/reserve-and-collect/) with a pound sterling value between £500 and £1,000 (the "Qualifying Transaction") during one of the Competition Periods. Explorer multi-currency MasterCard re-loads are exempt from this Prize Draw; and
  - (b) Opt-in to receive email marketing from Moneycorp at the point of ordering your currency at [www.moneycorp.com/en-gb/travel-money/reserve-and-collect/](http://www.moneycorp.com/en-gb/travel-money/reserve-and-collect/).
5. Subject to satisfying clause 4, you will be entered into the Prize Draw which was open at the time you successfully completed the Qualifying Transaction (a "Successful Entry").
6. Each Successful Entry will constitute an individual entry into the respective Prize Draw.
7. Moneycorp will carry out each respective Prize Draw at the end of each individual Competition Period. For each Prize Draw, one (1) winner will be selected at random from the participants and will be notified, via email, within fourteen (14) days of the Prize Draw taking place.
8. If the winner selected cannot be contacted, or has not responded within fourteen (14) days of being contacted, Moneycorp reserves the right to select another winner at random. Unsuccessful participants will not be contacted.
9. The prize for each Prize Draw is a set of Beats EP On-Ear Headphones in either white, red, black or blue (the "Prize").
10. The Prize will be sent to the winner by Royal Mail Special Delivery Guaranteed® and the winner must provide their full name, contact details and delivery address on being notified of winning the Prize Draw under clause 7.
11. The winner will be awarded the Prize within fourteen (14) days of satisfying Clause 10.
12. In the event that the Prize cannot be delivered to the winner and is returned to Moneycorp, Moneycorp reserves the right to select another winner at random.
13. Moneycorp offers no warranties in relation to the quality of the Prize and accepts no responsibility for any damage which occurs to the Prize once it is in transit to the winner.

14. The Prize is non-exchangeable, non-transferable and no cash alternative is offered.
15. Moneycorp reserves the right to replace the Prize with another prize of similar value in the event that the original prize offered is not available.
16. By entering into a Prize Draw, the participant consents to Moneycorp processing its personal data for the purposes of administering the Prize Draw. In the event of becoming a winner, the participant also agrees to Moneycorp sharing its personal data with Royal Mail Group Limited ("Royal Mail") for the purposes of awarding the Prize.   - d. in the event that the law or any regulatory guidance prevents Moneycorp from continuing the Prize Draws.

Events may occur which render the Prize Draws impossible due to reasons beyond Moneycorp's control and accordingly Moneycorp reserves the right, in its absolute discretion, to withdraw, amend or vary the terms of this Prize Draws at any time and you agree that no liability shall attach to Moneycorp as a result of such withdrawal, amendment or variation.
19. The Prize Draws are not open to Moneycorp employees or any member of their immediate family, namely a spouse, child, sibling or parent.
20. Moneycorp's decision regarding any aspect of the Prize Draws is final.
21. Your Qualifying Transaction is subject to Moneycorp's standard travel money terms and conditions, as amended from time to time.
22. Nothing contained in these terms and conditions is intended, or shall be deemed, to constitute or establish a partnership or joint venture between Moneycorp and Beats Electronics LLC – the supplier of Beats EP On-Ear Headphones.
23. These terms and conditions shall be construed in accordance with the laws of England and Wales.
24. Moneycorp and the participants agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with these terms and conditions or their subject matter or formation.
