2. To be eligible for this promotion you must (a) be a corporate or private international payments client of TTT Moneycorp Limited (“**Moneycorp**”); and (b) successfully complete foreign exchange transactions or international payments (each a “**Transaction**”) with a minimum aggregate value of £50,000 (or equivalent amount in any other currency as determined by Moneycorp), before 30th January 2026.
